Sexual Harassment Prevention /ICC Cell Policies

Sexual harassment prevention cell at an institute level typically implements policies focused on creating a safe environment by defining what constitutes sexual harassment, establishing clear reporting procedures, investigating complaints promptly, taking disciplinary action against perpetrators, and actively promoting awareness and sensitization programs for all staff and students through workshops and training sessions; all while upholding confidentiality and supporting victims throughout the process. Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (POSH Act).

Key aspects of such policies include:

Definition of Sexual Harassment:

A clear and comprehensive definition outlining various forms of sexual harassment, including verbal, physical, and non-verbal behaviors, to ensure understanding across the institute.

Internal Complaints Committee (ICC):

Establishing a dedicated committee with diverse representation (faculty, staff, students) to handle complaints, conduct investigations, and recommend appropriate actions.

Reporting Mechanism:

Clear guidelines for reporting complaints, including designated points of contact, methods of reporting (written, verbal), and provisions for anonymous reporting if needed.

Confidentiality:

Strict protocols to maintain the privacy of complainants and accused individuals throughout the investigation process.

Investigation Procedure:

A structured process for investigating complaints, including: Promptly informing the complainant and accused of the complaint. Gathering evidence, interviewing witnesses, and allowing both parties to present their side. Reaching a decision based on the evidence and taking appropriate disciplinary actions.




